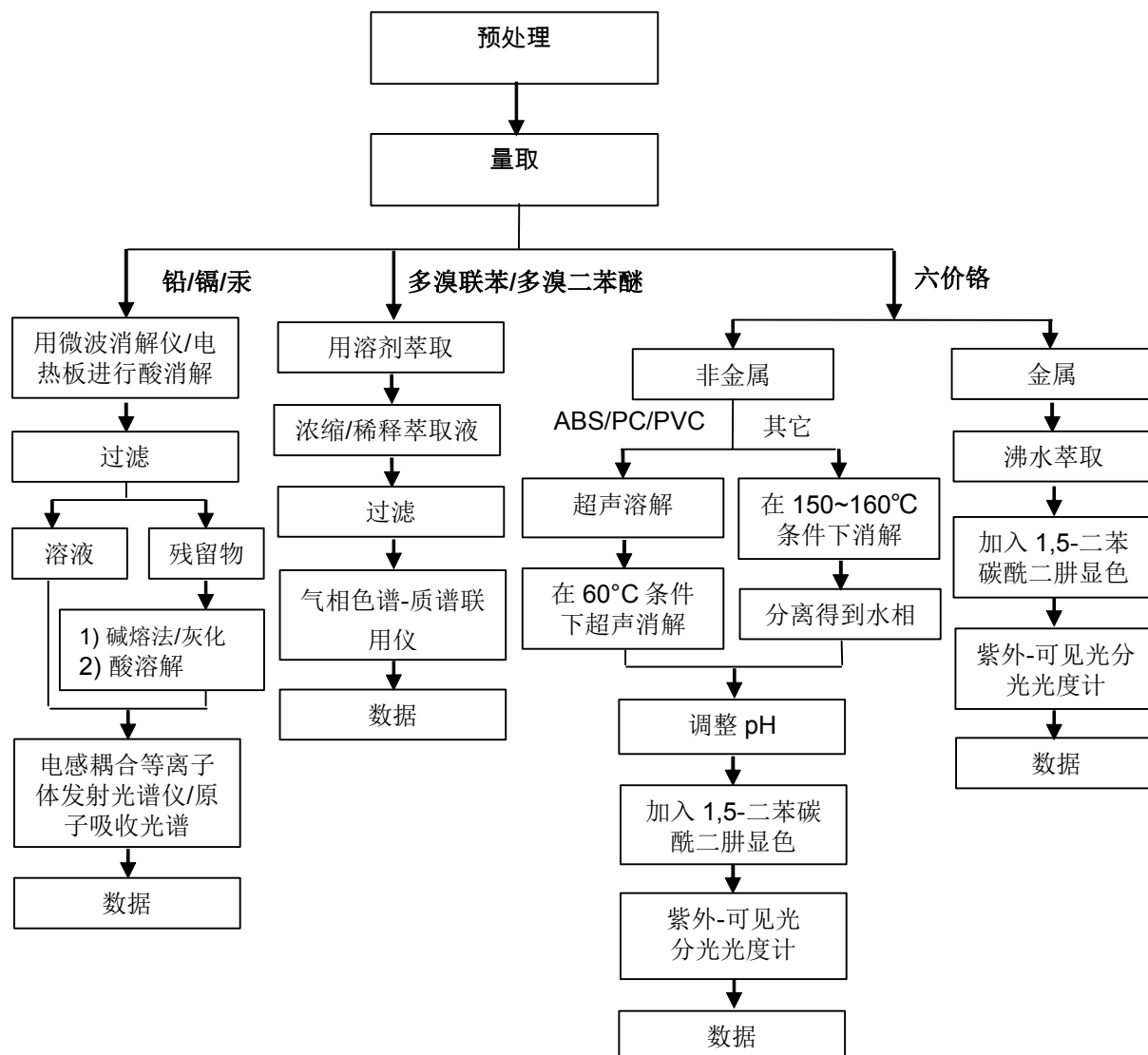

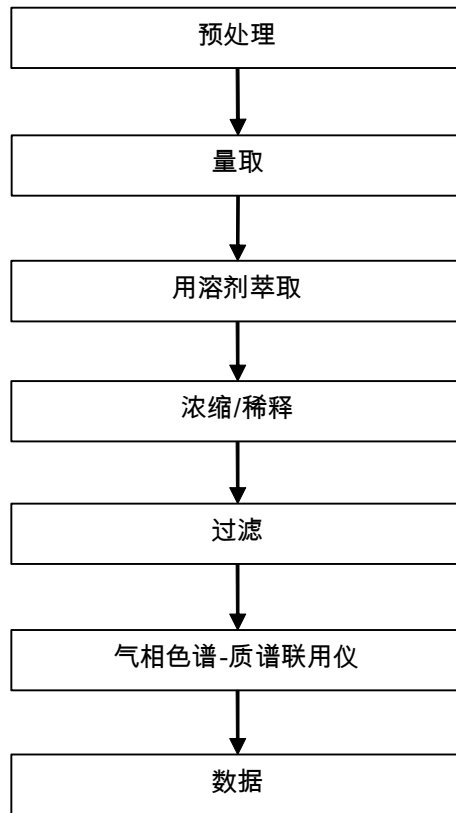
## Pb/Cd/Hg/Cr<sup>6+</sup>/PBBs/PBDEs 测试流程图

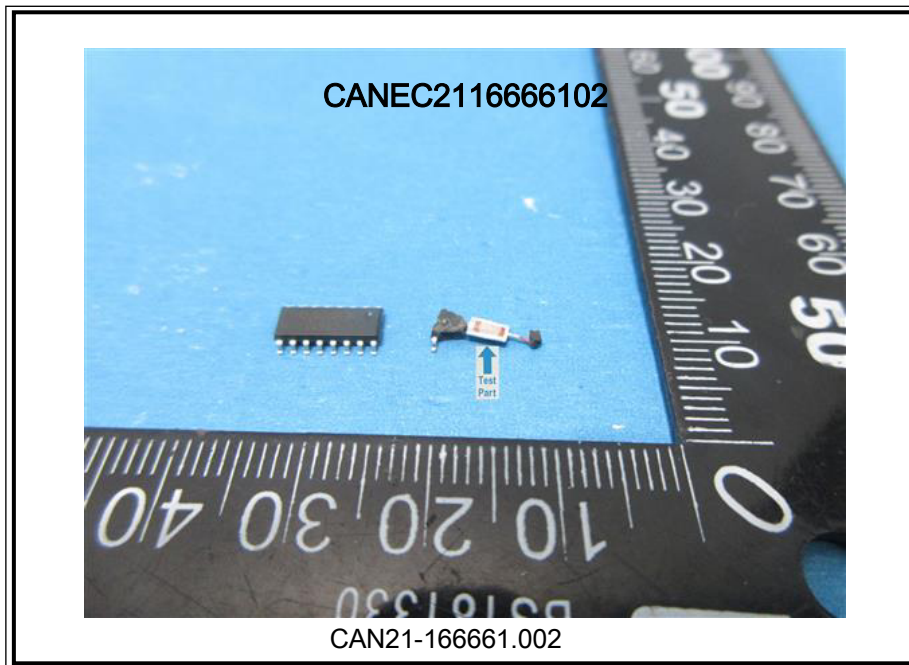
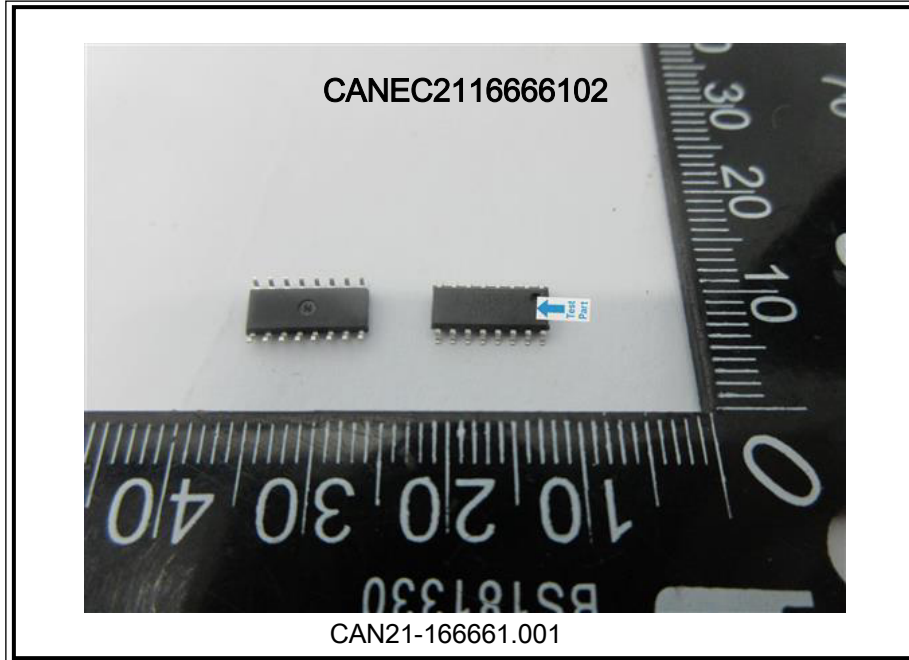
### Phthalates 测试流程图

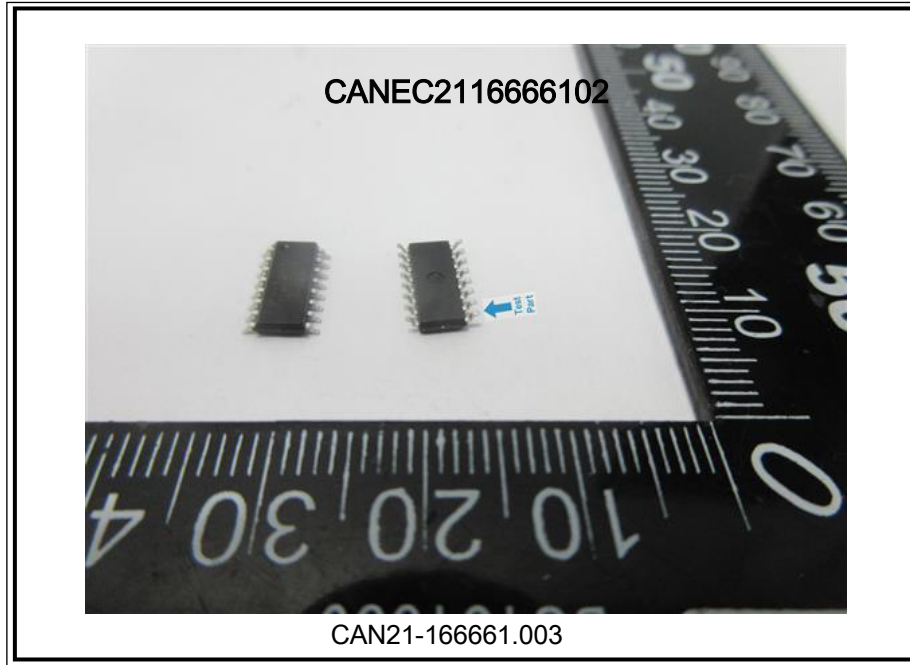
